LEGAL PROVISIONS TO CITE

Guardianship and Administration Act 1990 (WA)

Section 4 - Presumption of Capacity

Every adult is presumed to have capacity unless proven otherwise. The burden of proof is on the applicant, not the respondent.

Section 69 - Least Restrictive Alternative

The Tribunal must impose the least restrictive alternative possible.

Section 72 - Matters to be considered

The Tribunal must consider the person's wishes, the views of family, and the least restrictive option.

Equal Opportunity Act 1984 (WA)

Part IVA - Discrimination on the ground of impairment

A person discriminates if they treat someone less favourably on the ground of their impairment or a characteristic generally imputed to persons with that impairment.

Section 66G - Qualifying bodies

It is unlawful to refuse or fail to confer, renew or extend an authorisation needed for carrying on a trade or business on the ground of impairment.

State Administrative Tribunal Act 2004 (WA)

Section 29 - Tribunal to act fairly

The Tribunal must act fairly and according to the substantial merits of the case.

3. Company is real, registered, with tangible products accessible online
4. Psychologist confirmed capacity
5. No history of financial mismanagement
6. Top of NEIS class, denied continuation due to orders
7. Wife's death directly caused by financial restrictions

Psychologist Testimony (if available)

1. Confirmed capacity to manage financial affairs
 2. Schizoaffective disorder does not impair financial decision-making when medicated
 3. No evidence of delusional thinking regarding business ventures

REMEDIES SOUGHT (Summary)

1. **Immediate revocation** of administration order (GAA ¹⁵⁶⁶/2024)
 2. **Declaration** that original decision was based on discrimination
 3. **Compensation** of \$441,000+ for financial losses
 4. **Reimbursement** of all Public Trustee fees
 5. **Costs** of this appeal

PRESENTATION TIPS

- **Stay calm and professional** - You are proving your capacity through your conduct
 - **Speak clearly** - Address the Presiding Member as “Your Honour”
 - **Use evidence** - Reference specific documents and online resources
 - **Be factual** - Stick to verifiable facts, not emotions
 - **Show respect** - Even when describing discrimination, remain respectful
 - **Demonstrate capacity** - Your articulate presentation is itself evidence
